
COMPANY PROFILE

These can include upheaval situations with extensive restructuring requirements or unresolved succession situations and group carve-outs. The focus of an investment decision is a clear view of the company's potential for value growth. With its cross-sector expertise, Blue Cap supports its portfolio companies in their strategic and operational development in order to actively increase their enterprise value and subsequently sell the company at a profit. Blue Cap currently holds majority stakes in eight companies from the adhesives & coating technology, plastics, production, medical technology and business services sectors. The group employs more than 1,000 people in Germany and other European countries as well as the USA.
